Scholarship Guidelines

The Erin's Law Foundation announces its Scholarship Program. A \$500 scholarship will be awarded to two (2) qualified applicants based upon criteria and a selection process determined by the Foundation in its sole discretion.

Program Guidelines & Priorities:

- * Seeking two (2) graduating high school seniors (or continuing college, university or trade school students) with a passion for community service and an intention to continue their education at an accredited college, university or trade school.
- * Applicants must be persons who are survivors of sexual abuse and assault, encourage others, are respectful and respected with a demonstrated commitment to and involvement in their community.
- * Scholarship funds will be paid ***in August or September 20__ for the first semester of each student's first academic year directly to the college or university*** and not to the student. It will be each student's responsibility to submit to the Foundation an invoice for first semester tuition and fees, student ID number and college or university information.
- * Applicants must have the endorsement of their Guidance Counselor on their application attesting that they are a qualified fit for this scholarship program. ***The Foundation strongly suggests that each high school present this opportunity to the strongest applicants that match this program's guidelines.*** Application deadline is **May 31, 20__ by 5:00 p.m.** to be received by the Foundation. Late applications will not be accepted.
- * Each applicant selected as a scholarship winner must be present at any potential awards ceremony, surprise or reception to receive his or her scholarship award.
